Terms and Conditions of Participation in PS87 Afterschool Program

I understand and agree:

- 1) that this payment is for the Spring 2012 term; that I shall not be entitled to any deduction for my child's absences during the term; and that in the event of my child's withdrawal from PS87 Afterschool Program, I have read and agree to the terms of the Program's Refund Policy:

REFUND POLICY

If a family drops a class within the first 3 weeks of the session, refunds will be issued (less \$35 nonrefundable registration fee), with written request received by PS87 Afterschool Program, according to the following schedule:

- 100% tuition refund with written notice received 1 week prior to 1st scheduled class session.
- 75% tuition refund with written notice received 2 days prior to the 2nd scheduled class session.
- 50% tuition refund with written notice received 2 days prior to the 3rd scheduled class session.

After the third scheduled class session, no refunds or credits will be granted.

- 2) that if I have indicated that if my child is entitled to reduced-rate tuition, I must verify my eligibility with appropriate documentation; and that if I do not meet eligibility requirements, that I must pay full-rate tuition to the Afterschool Program;
- 3) that the Program cannot issue refunds for any clubs not attended or not held due to half-day or full-day closures by the Department of Education;
- 4) that the Program requires my child to meet certain standards of behavior and that if my child fails to behave or demonstrates repeated unsatisfactory conduct, the Program has the right to transfer my child to another club, or dismiss my child from the Afterschool Program, without refund or credit for unused tuition;
- 5) that if my child is not picked up by 6:00 PM, I agree to pay late fees according to Program policy, and that my child may be taken to the 20th Precinct in the event no one is available to supervise my child after 6:30 PM;
- 6) that if my child is injured and requires medical attention and I cannot be reached for instructions, I do hereby give authority to PS87 Afterschool Program to obtain necessary emergency medical treatment for my child with the understanding that the family will be notified as soon as possible;
- 7) that in consideration of PS87 PA Inc. conducting the Afterschool Program and allowing my child to participate in such program, I hereby release and forever discharge PS87, PS87PA Inc., and PS87 Afterschool Program and its officers, volunteers, employees, contractors, and agents from any liability arising out of or based upon any bodily injury or property damage sustained by my child while participating in such program;
- 8) that during Afterschool activities my child may be photographed or filmed by PS87 Afterschool Program personnel or its authorized agents for internal or promotional use;
- 9) that some PS87 Afterschool Program clubs may involve trips outside the PS87 building supervised by staff of the PS87 Afterschool Program. I give my child permission to go on any such trips organized as part of the PS87 Afterschool Program.
